## Annex A: Individual Payment Schedule Sample Dates

1. For fall semester intake, payments are due according to the following schedule:
  - 1.1. Annually: 1 instalment payable on or before 30 September;
  - 1.2. By semester: 2 equal instalments on 30 September and 02 January; or
  - 1.3. Monthly: 8 equal instalments starting in September and ending in April.
2. For spring semester intake, payments are due according to the following schedule:
  - 2.1. Annually: 1 instalment payable on or before 02 January;
  - 2.2. By semester: 2 equal instalments on 02 January and 30 September; or
  - 2.3. Monthly: 8 equal instalments with a batch of four monthly instalments starting on 02 January and ending 01 April, and four further monthly instalments starting on 01 September and ending 01 December.
